#1 - Call to Order/Record of Attendance/Excused Absences: Vice-Chair Paul Schmidt brought the meeting to order at 1:01 pm.

Vice Chair Schmidt announced that members Mary Kuney and Tony Harbolt requested to be excused from the meeting.

Ms. Cragun made a motion to excuse the absences. Mr. Gribner seconded. Motion carried unanimously.

Vice Chair Schmidt reported that Mayor Wick had a prior meeting that is running late. In order to allow for his presence for Agenda Items 2 and 3, he would entertain motion to re-order the agenda for Items 2 and 3 to occur after Agenda Item 6.

Ms. Kuney made a motion modify the agenda as described. Ms. Cragun seconded. All votes were in favor.

4 Public Comments

There were no public comments.

5 Interim Executive Director's Report

Mr. Wallace reported on:

- The region exceeded federal obligation target by approx. \$1.5M. SRTC received notice from Spokane Regional Health District of the intent to de-obligate the Safe Routes to School and Walk-Bike-Bus programs due to resource challenges, but because of timing these de-obligations will not impact the obligation target.
- There is currently a solicitation out for Federal RAISE grants and applications due 7/12. Contact the SRTC office if a letter of support is desired.
- Staff is continuing to work on the Unified List of Regional Transportation Priorities. There have been several recent updates from member agencies and a revised list will be emailed to Board members after today's meeting. This topic will be discussed again at the August Board meeting.
- SRTC Board Chair sent Board membership invitations to the Spokane and Kalispel Tribes and we
 are waiting for a reply. SRTC received notification from WSDOT that extending the invitation meets
 the legal requirements.
- Staff held a public meeting on June 30 for the metropolitan transportation plan update; a public survey has been launched as well as a promotional video, and a link to the video will be sent to Board members.

ACTION ITEMS

6 Consent Agenda

- (a) June 2021 Meeting Minutes
- (b) June 2021 Vouchers
- (c) 2021-2024 Transportation Improvement Program (TIP) June Amendment

Ms. Thompson asked that the June minutes be considered separately.

Mr. Ewers made a motion for approval of Consent Agenda items (b) and (c); Ms. Mumm seconded. Motion passed unanimously.

Ms. Thompson said that the June minutes did not include her name on the list of Board members attending and she was at the meeting. Staff will make that correction.

Ms. Cragun made a motion to approve the June minutes as amended. Ms. Thompson seconded. Motion carried with all votes in favor.

Vice Chair Schmidt asked for a motion to modify the agenda as Mayor Wick had not yet joined the meeting.

Mr. Stone made a motion to proceed to Agenda Item 7. Ms. Thompson seconded. Motion passed unanimously.

#7 Maintenance and Preservation Project Priorities

Mr. Wallace recapped; in April the Board began working to establish a *Unified List of Regional Transportation Priorities* which should be completed by October, at which time it will be turned over to member agencies and private sector interests as they begin to develop state and federal transportation agendas for the 2022 legislative session. An update to the *Unified List of Regional Transportation Priorities* will be presented at the August Board meeting.

In June the Board discussed the possibility of a special state legislative session (where a transportation package might be considered) and instructed staff to coordinate with member agencies develop a list of potential preservation and maintenance projects for Board review and approval.

Mr. Wallace said in addition to the list of preservation and maintenance projects, staff has crafted a funding priority statement based prior statements approved by the Board in February. He said if the Board approves the statement today, it will be available to member agencies and private sector to prepared for discussions with legislators prior to the possible special session later this year.

He described and provided details about the three priority statements; he shared examples about needs in the region related to why these statements are important. A draft list of projects was presented that included the unfunded need amounts and whether the project was on the National Highway System, or a transit or bicycle project; he emphasized the list is not prioritized.

The group discussed and some questions/comments included:

- There is not a stand-alone pedestrian priority network; pedestrian projects fall under the multi-use facility.
- It might be helpful to include information about number of potential users of a project or levels of service. Mr. Wallace said staff may be unable to obtain this information for all projects, but will for as many as possible.
- In favor of this move away from project specific discussions for maintenance and preservation and instead focusing on driving more programmatic dollars to the region.

Ms. Fukai made a motion to approve the Transportation Funding Priority Statement as presented. Mr. Ewers seconded. Motion carried with all votes in favor.

Mr. Beggs joined the meeting at 1:30.

Vice Chair suggested that the agenda move to the Information & Discussion items beginning with Agenda Item 8 and continue until Mayor Wick is able to join the meeting, at which time the meeting move to consideration of Agenda Items 2 and 3.

Ms. Cragun made a motion to approve the proposed agenda modification; Mr. Weathers seconded. Motion carried unanimously.

INFORMATION & DISCUSSION ITEMS

#8 Call for Preservation Projects

Mr. Lien said this item will be brought before the Board next month for action. He summarized how funds were set aside by the Board from the 2018 SRTC Call for Projects to be used for preservation projects in 2022/2023 and the Board also approved a policy for SRTC to hold a biennial "preservation only" call for projects. In February the Board approved four principles of investment for the 2021 Call for Projects:

- 1. Limiting the call to preservation projects only
- 2. Cap awards at \$1M per project
- 3. Cap awards at \$2M per agency
- 4. Adhere to funding requirements for STBG funding awards to include rural and small cities

He said SRTC received 18 project applications and scoring was done by a group made up of Transportation Technical Committee (TTC) members, Transportation Advisory Committee (TAC) members and SRTC staff. 11 of the projects are located in the urbanized area, one in small city urban and the rest in the rural category. Mr. Lien reviewed the preliminary results, requested dollar amounts, and the funding available by category.

He asked the group to consider (1) whether to fully fund fewer projects as opposed to partially funding a larger number of projects and (2) how to apply the remaining flex funding. He noted that the TAC discussed this topic last month and they expressed interest in exploring what could be done for the small Palouse towns to help their applications score higher in future calls for projects.

The group discussed:

- The pros and cons of fully funding fewer projects or partially funding more projects
- Urban Small category and definition of FHWA urbanized areas
- Difficulties for small towns to get access to funding because of lack of resources to submit application
- Possibility of re-evaluating small town project scoring, which would be a policy decision for a future call for projects. The Board could decide to create a new category.
- Population isn't the only effective metric for evaluating applications; perhaps traffic volume could be a metric.

Chair Wick joined the meeting and Vice Chair Schmidt turned the meeting over to him.

2 Executive Session to Evaluate the Qualifications of Applicants for Public Employment under RCW 42.30.110(g)

Chair Wick asked for a motion for Board members to move into Executive Session for the purpose of Evaluating the Qualifications of applications for public employment, under RCW 42.30.110(g). He noted the session would last approximately 20 minutes.

Mr. Schmidt made a motion to move into Executive Session as described; Ms. Thompson seconded. Motion passed unanimously.

- At 1:55 the Executive Session began, but due to technical difficulties in getting Board members into the virtual breakout room, the initial 20-minute timeframe was extended by a few minutes.
- Mr. Freeman was attending the meeting by telephone and unable to join the breakout room for the
 Executive Session. He stated that he had not been part of any prior Executive Director recruitment
 discussions and recused himself from the Executive Session. He left the meeting at 1:58.
- At 2:15 it was announced the Executive Session would last another 5 minutes.
- At 2:25 the Executive Session ended, and the regular session commenced.

#3 Selection of SRTC Executive Director

Chair Wick recapped the Executive Director search/recruitment process and thanked the recruitment committee members for a very thorough and thoughtful process.

Ms. Meyer made a motion to approve the hiring of Lois Bollenback as the new SRTC Executive Director under the terms recommended by the committee. Mr. Schmidt seconded the motion. The vote passed with all votes in favor.

Ms. Cragun made a motion to add Item 3(a) Establishment of new SRTC Deputy Executive Director Position to the meeting agenda. Ms. Meyer seconded. All votes were in favor.

3(a) Establishment of SRTC Deputy Executive Director Position

Mr. Schmidt made a motion for the establishment a new SRTC Deputy Executive Director position with a salary range of \$90,000 to \$120,000. Ms. Thompson seconded. Motion carried unanimously.

9 Public Participation Plan (PPP) Update

Ms. Jones provided an overview of the PPP and the development of the update thus far. She explained that a group of TAC members and staff have held five in-depth workshops to evaluate the following plan components:

- Develop Goals and Objectives
- Stakeholder Engagement Matrix
- Equitable Public Participation Techniques & Methods
- Evaluation Matrix
- Administrative & Other

She highlighted activities and outcomes from the workshop on equitable outreach and explained the three plan goals developed by the group.

Ms. Fukai commented that meaningful engagement with hard-to-reach communities can be time and resource intensive and just to make note of that for budget planning purposes. She said sometimes communities can be distrustful of governmental agencies and there can be a gap in understanding about how transportation issues matter. An ongoing educational focus and stressing the importance of community opinion is an ongoing process. Ms. Jones spoke about making community connections.

10 2022 Member Dues

Mr. Griffin reviewed the dues structure as outlined in the 2021 Interlocal Agreement. He said there was a three-year plan to increase dues by 15% per year, but this was suspended for 2021 dues in light of economic impacts of the pandemic. He provided a history of prior dues discussions and increases. A proposed 15% increase for the 2022 dues will be brought before the Board next month.

11 Return to In-Person Meetings

Mr. Griffin explained that as the public health restrictions continue to lift, SRTC would like to begin holding Board and committee meetings in a hybrid in-person/virtual format. However, as equipment purchases and logistics are still under development, it may be prudent to plan on the August Board meeting to be on the virtual platform. He noted that as the number of Board members has recently expanded due to the revised Interlocal Agreement, the Riverside Room may be too small to comfortably accommodate all Board members, staff, and the public. He asked for Board their suggestions or ideas about alternative venues.

Mr. Gribner reported that WSDOT is currently making substantial investments in upgrading conference rooms to allow for hybrid meetings, but not sure when the changes will be complete. Mr. Weathers suggested that Airway Heights Recreation Center has a room that is large enough but doesn't know what technology is available. Mr. Schmidt said that staff and the new Executive Director can continue exploring options. Chair Wick stated that holding a virtual August Board meeting was acceptable.

12 2021 Quarterly Budget Update: Q2 (Apr-May-Jun)

Mr. Griffin provided an overview of the 2021 budget and revenues/expenditures to date. There were no questions or discussion.

13 Board Member Comments

Ms. Meyer commended Chair Wick, Mr. Wallace, and the other members of the recruitment committee for their hard work which has come to a very successful end. She said SGR was an excellent recruitment firm and was very impressed with them. She noted that Mr. Griffin provided good support throughout the process and she can't say enough about the quality of the search and the outcome.

14 Adjournment

There being no further business, the meeting adjourned at 2:59 pm.

Requested Action:

Approval of the August amendment to the 2021-2024 TIP as shown in the **Attachment**.

Key Points:

Two agencies have requested amendments to the 2021-2024 TIP. See **Attachment** for more details.

- City of Spokane Valley: S. Sullivan Road Preservation
- City of Spokane Valley: Mission Ave. Bridge Deck Repair
- City of Spokane: Division St Pedestrian Hybrid Beacons
- City of Spokane: Hatch Road Latah Creek Bridge Deck Repair

TIP Overview

The TIP is a programming document that identifies specific projects and programs to be implemented during the upcoming four years. Any project with federal funds from the Federal Highway Administration (FHWA) or Federal Transit Administration (FTA), as well as any regionally significant projects, must be included in the TIP. After a TIP has been incorporated into the Washington State TIP (STIP), project changes can be requested by local agencies. Minor changes can be made administratively by SRTC staff. Significant changes must be made through the amendment process, which requires a 10-day public comment period and action by the SRTC Board of Directors.

Board/Committee Discussions:

On 07/28/21 the Transportation Technical Committee unanimously recommended Board approval of the proposed August TIP amendment.

Public Involvement:

Pursuant to SRTC's Public Participation Plan, this amendment was published for a public review and comment period from 07/21/2021 through 07/30/2021at 4:00 p.m. Notice of the amendment was published in the Spokesman Review, posted to the SRTC website (www.srtc.org), and to social media platforms on 07/21/2021. No public comments were received.

Supporting Information/Implications:

The TIP serves as an important tool in implementing the goals, policies, and strategies identified in Horizon 2040, SRTC's long-range plan. As such, any projects included in the TIP, including projects added through monthly amendments, must be consistent with Horizon 2040. Consistency with Horizon 2040 includes a demonstration of financial constraint and conformity with regional air quality plans. The August amendment has been reviewed by SRTC staff for compliance with federal and state requirements and consistency with Horizon 2040.

TIP amendments must be approved by the SRTC Board to be incorporated into the Washington State TIP (STIP). Projects receiving federal funds must be in both the TIP and the STIP to access those funds.

Pending approval by the SRTC Board, the August amendment will be incorporated into the STIP on or around September 17, 2021.

Topic: Calendar Year (CY) 2022 Member Dues

Requested Action:

Approval of SRTC member dues for CY 2022 based upon the population formula and allowable 15% increase as outlined in the SRTC Interlocal Agreement.

Key Points:

- The Washington State Office of Financial Management's (OFM) 04/01/2021 population estimates are used to calculate dues.
- Due to the evolving economic impacts of the COVID pandemic in 2020, year three of a three-year plan to increase dues 15% per year was postponed from the 2021 budget cycle to 2022. The per capita dues rate will increase from .26 to .30 per capita.
- The Interlocal Agreement contains a provision for the City of Spokane and Spokane County to have the same membership dues based on City of Spokane population.
- The 2021 SRTC Interlocal Agreement (ILA) contains an allowance for up to a 15% increase in local dues without a one-year notice to members.
- Approval of a 15% increase for all members would result in total dues increase for CY 2022 of \$36,719 over CY 2021 dues.
- The 2021 ILA update offers membership to the Kalispel Tribe of Indians and the Spokane Tribes of Indians. Pending membership acceptance and determination of dues to be determined.
- A draft CY 2022 Budget will be presented to the Board for information in October 2021 and for action in November 2021.

Board/Committee Discussions:

This item was presented to the Board for information and discussion at the July 8, 2021 meeting.

While SRTC committees do not have direct input into dues or budget, they are substantially involved in the development of the Unified Planning Work Program (UPWP), which is the key document used in the creation of the agency's budget.

Public Involvement:

The 7/08/2021 Board meeting was open to the public; information announcing the meeting was published on a variety of platforms.

Supporting Information/Implications:

SRTC revenues are disproportionally funded by federal and state grants. In CY 2021 budget 8.5% of agency revenue is from membership dues. On multiple occasions over the past few years the Board has discussed a desire to seek a better balance of funding sources.

Activities in the CY 2022 budget follow the SRTC Strategic Plan and 2022-2023 UPWP. Health insurance benefit costs are expected to increase moderately compared to prior years. The D.A.T.A. project will have significant match requirements, estimated to be \$94,500 for CY 2022.

Each year SRTC develops an annual budget outlining anticipated revenues and expenditures for the following year. The CY 2022 budget preparation schedule is:

The draft CY 2022 budget is prepared within the framework of the Board's priorities for the agency. The budget focuses available resources on planning activities as outlined in the 2022-2023 Unified Planning Work Program (UPWP), which was approved by the Board on 06/10/2021.

The budget categories are used to track actual revenues and expenditures throughout the year and quarterly reports are provided to the Board. The 2021 ILA calls for the SRTC Board to provide a proposed work program and total budget to each member agency by September 15 of the preceding year. Approval or rejection of such budget by each member shall be submitted to SRTC by November 1 of each year.

Topic: Transportation Improvement Program (TIP) Call for Preservation Projects

Awards

Requested Action:

Approve project awards for the 2021 Call for Preservation Projects, as outlined in the Attachment.

Key Points:

- In 2018 the SRTC Board set aside \$6M of Surface Transportation Block Grants (STBG) during the 2018 Call for Projects to fund capital maintenance and preservation projects to obligate and deliver in 2022 and 2023.
- In October 2020 the SRTC Board approved a new TIP policy to hold a preservation call for projects every two years to assist the agency in meeting our federal funding obligation targets.
 Preservation projects are generally less complicated and add certainty toward project delivery.
- SRTC released a Call for Preservation Projects in March 2021. Eight agencies submitted \$12M in project requests.
- SRTC convened a multi-agency scoring team consisting of three TTC Members, two TAC Members, and two SRTC Staff Members to score project applications. Additionally, a threeperson multi-agency team of pavement specialists reviewed and verified all the pavement conditions in the submitted applications.
- In March 2021 the SRTC Board approved the following investment principles to apply to awarding projects.
 - Limit awards to a maximum of \$1M per project so multiple projects can be funded. This
 is suggested to prevent any one large project from potentially absorbing most of the
 available funding.
 - 2) Limit any one jurisdiction to a maximum of \$2M in total awards, for geographical distribution.
- Federal and state funding requirements ensure that rural and small cities are distributed a
 portion of the awards. The rural and small city combined awards must be at least \$804,437 and
 not greater than \$1,653,000 of the total \$6M available.
- The Attachment contains the recommended distribution of awards based on the top application scores by geographic category, local agency priority, and the Board-approved investment principles.

Board/Committee Discussions:

The Call for Projects preliminary results were shared at the June TTC and TAC meetings as well as the July Board meeting. At the July TTC and TAC meetings, both committees voted to recommended approval of the project awards shown in the attachment.

Public Involvement:

All Board and committee meetings are open to the public. When additional funds are allocated to projects by SRTC, a TIP Amendment 10-day public comment period will be opened.

Supporting Information/Implications:

The recommended project awards (shown in attachment) were supported for approval by both the TAC and TTC. The recommended awards are based on the following:

- #1 scoring Urbanized Area project Full award of request
- #2 scoring Urbanized Area project Full award of request
- #4 scoring Urbanized Area project Full award of request. #3 project skipped from the same agency due to #4 being the top priority as noted by the agency. With that, Spokane Valley is at \$2M in maximum awards per the investment principles.
- #5 scoring Urbanized Area project Full award of request
- #7 scoring Urbanized Area project Project awarded the remaining minimum in the Urbanized Area category. #6 project skipped from the same agency due to #7 being the top priority as noted by the agency. Flexible funding applied to get to full award of request. With that, Spokane is \$281,500 away from the \$2M in maximum awards per the investment principles.
- #1 scoring Rural project (#10 overall score) Full award of request
- #1 scoring Urban Small project (#11 overall score) Project awarded the minimum in the Urban Small category. Flexible funding applied to get to full award of request.
- #2 scoring Rural project (#12 overall score) Project awarded the remaining minimum in the Rural category. Remaining flexible funding balance applied to award 88% of the funding request. Spokane County has indicated they can deliver the project awarded at 88%. \$0 balance remains of the \$6M available in the Call for Projects.

Discussion and action to approve preservation project awards will be sought at the August 12 meeting. The 2022-2025 TIP will be drafted with the project awards approved by the Board.

Topic: Transportation Funding Priority Statement for 2021 Washington State Legislative

Special Session

Potential Action:

Opportunity to add a fourth priority statement to the SRTC Transportation Funding Priority Statements for a 2021 Washington State Legislative Special Session (see Attachment).

Key Points:

- Several transportation funding proposals were introduced during the Washington State Legislature 2021 session in both the House and Senate, but the legislature concluded the session without approving a new transportation revenue package.
- Speculation continues as to whether the Governor will convene a special session later this
 year to finalize or start a brand-new transportation package. At this time, staff has been
 informed that a special session could be called in late October or early November.
- On July 8, 2021, in preparation for a potential 2021 special session the SRTC Board approved the following three priorities for a Transportation Funding Priority Statement, see Attachment, Priority One, Two and Three for the full language:
 - o <u>Priority One</u>: Completion and Acceleration of the Connecting Washington Program
 - <u>Priority Two</u>: Increased Funding for Transportation System Preservation and Maintenance
 - <u>Priority Three</u>: Maintain Funding for Projects Identified in the Forward Washington and Miles Ahead Washington Spending Bills
- SRTC has been contacted by various members regarding the possibility of a fourth priority statement considering that a brand-new revenue package may be developed.
 - <u>Draft Priority Four</u>: Targeted investments to improve safety, condition, and operations to maintain quality of life and economic vitality in the region as we experience continued growth.
- In the **Attachment**, List of Regional Transportation Priorities-Priority 4 Projects, present a starting point for Board discussion on a potential fourth priority statement. If the Board chooses to develop a fourth priority statement, the entire list or partial list of Priority 4 Projects could be included in the SRTC Transportation Funding Priority Statements.
- On July 29, SRTC presented the SRTC Transportation Funding Priority Statements One,
 Two and Three to the Regional Transportation Coalition (RTC) which is a consortium of local

chambers of commerce and public and private sector representatives that do advocacy work for transportation investments. RTC indicated their strong support of the statement and adding a fourth priority statement to advocate for a potentially large transportation revenue package.

 Discussion varied among those at the RTC meeting, some indicating support for including all Priority 4 Projects and some only supporting projects that would not increase the regional burden of maintenance and preservation by adding new roadway capacity. This is due to a \$711 M combined preservation backlog recently reported by WSDOT, Spokane County, City of Spokane, and City of Spokane Valley.

Board/Committee Discussions:

On June 10 and July 8, the SRTC Board discussed the potential for a special legislative session, and the need for a new list of preservation and maintenance priorities. On July 26 and 28, SRTC Staff updated the TAC and TTC on this work effort as part of the Agency Update.

Public Involvement:

All Board meetings are open to the public.

Supporting Information/Implications

- The SRTC Board is the lead agency for coordinating regional transportation issues in Spokane County. The Board-approved Transportation Funding Priority Statement establishes a framework for discussions with area legislators, SRTC member agencies, and local business interests. As discussed previously, SRTC serves both technical and facilitation roles in this process. Discussions with area legislators leading up to a potential legislative session would be undertaken by SRTC's member agencies and area business interests.
- If the SRTC Board approves a fourth priority for the WA Legislative Special Session and a transportation revenue package is not approved, the Board may wish to consider maintaining the new Transportation Funding Priority Statement for the 2022 WA State Legislative Session to convey a consistent message.
- Under Board advisement, SRTC Staff could continue work on the Unified List of Regional Transportation Priorities for a 2022 Federal Agenda. The Unified List would identify 20-25 projects and maintain the schedule for Board approval in October 2021.

Spokane Regional Transportation Council 2021 TRANSPORTATION FUNDING PRIORITY STATEMENT

Spokane Regional Transportation Council (SRTC) is both the Metropolitan Planning Organization (MPO) and Regional Transportation Planning Organization (RTPO) for Spokane County. SRTC provides regional transportation leadership and coordination by conducting comprehensive, cooperative, and continuing transportation planning with representatives from local jurisdictions, Tribes, Transportation providers and local stakeholders. SRTC works to ensure that transportation projects and programs are based on mutually agreed upon goals and priorities developed in an impartial and non-partisan platform.

In anticipation of a special State legislative session in late 2021 during which transportation funding may be discussed, this document can serve as a framework for conversations with area legislators and local business interests. Using the regional planning process, the following transportation funding priority statement was endorsed by the Spokane Regional Transportation Council Board of Directors on July 8, 2021.

PRIORITY ONE

COMPLETION AND ACCELERATION OF THE CONNECTING WASHINGTON PROGRAM

The 2015 Connecting Washington funding package provides \$16 billion to enhance the statewide transportation system and to maintain critical infrastructure. Since 2015, other emerging transportation requirements could potentially jeopardize funding that was allocated in Connecting Washington projects in our region.

The SRTC Board supports efforts to maintain funding for the following Connecting Washington projects:

- US 395/North Spokane Corridor
- I-90/Medical Lake I/C to Geiger Field Interchange Reconstruction
- I-90/Barker to Harvard
- The City Line

Additionally, the Board supports the advancing funds to complete the NSC in 2026 than 2029 as currently programmed.

PRIORITY TWO

INCREASED FUNDING FOR TRANSPORTATION SYSTEM PRESERVATION & MAINTENANCE

The SRTC Board recognizes that current funding levels are not sufficient to maintain our current transportation system in a state of good repair. The Board also recognizes that failing to adequately preserve and maintain the transportation system presents significant risks to our overall economic well-being and to the operating efficiency for moving people and goods in our region. The following information about shortfalls on the state system illustrates the significance of this issue:

In Spokane County, the Washington State Department of Transportation (WSDOT) has identified approximately an \$80.2 million backlog in preservation needs. Local jurisdictions have identified the following preservation backlogs; City of Spokane \$240 million, City of Spokane Valley \$100 million, and Spokane County \$291 million. This results in a combined total of \$711.2 million preservation backlog.

The SRTC Board supports increased funding for existing programs for the preservation and maintenance of the state and regional transportation networks. The Board recognizes this as a long-term solution to address preservation and maintenance needs. SRTC has included a list of representative maintenance and preservation projects that could be addressed with increased funding, see representative Priority 2 Projects and Map.

This version of the List of Regional Transportation Priorities has not been fully confirmed with all sponsor agencies but represents the best available data as of August 5, 2021. This version of the list does not represent the final list as adopted by the SRTC Board. A final list is not expected to be adopted until October, 2021.







- Based on the proposals submitted and results of the interviews, the Subcommittee recommends that Etter, McMahon, Lamberson, Van Wert & Oreskovich, P.C. be selected to serve as SRTC's new Legal Counsel.
- On behalf of the staff, I would like to thank Stanley Schwartz for his many years of service to SRTC.

Topic: Metropolitan Transportation Plan, Horizon 2045 - Chapters 1 and 2

Requested Action:

For information and discussion.

Key Points:

- SRTC staff, in coordination with the TTC, has been working to update the Metropolitan Transportation Plan (MTP) since Summer 2019.
- The region's Metropolitan Transportation Plan, Horizon 2045, is not only a federally required plan, but it is central to the region's transportation planning and investment.
- The MTP is a long-range planning document that identifies transportation challenges, policies, strategies, and projects over the next two decades.
- The Plan is a critical policy document that guides future transportation investments in the region.
- Growth projections and travel forecasts contained in the plan help identify areas of potential future investment.
- Horizon 2045 is multimodal and addresses walking, cycling, transit, freight and personal vehicle modes of transportation.
- The SRTC Board has been updated throughout the course of the past two years and has taken action on several components of the update.
- A page on the SRTC website has been developed for <u>Horizon 2045</u>.
- At the August meeting, staff will provide a general update on the Plan's status and an overview of draft chapters 1 and 2.
- Over the course of the next several months the Board will be presented the remainder of Horizon 2045 and ultimately take action on the Plan in December.

Board/Committee Discussions:

The SRTC Board has been briefed on the elements being updated in Horizon 2045. The below table details Board touch points to date. The Board will continue to receive presentations on the updated plan, broken into sections, monthly through the end of the year. In December, staff will be requesting an action to adopt the plan.

The pavement system is one of the highest value assets owned by local jurisdictions. Research undertaken to update SRTC's Long Range Transportation Plan indicates that local agencies are not keeping pace with street preservation and maintenance needs. Information presented for this agenda item will illustrate how the City of Spokane Valley is addressing this important issue.

MEETING SUMMARY

Spokane Regional Transportation Council 07/26/2021 Transportation Advisory Committee (TAC) Meeting Zoom Video Conference

Action Items

- Approval of June meeting minutes passed unanimously.
- TIP Call for Preservation Projects Mr. Jason Lien recapped the background of the \$6M call for preservation projects, the principles of investment approved by the Board, and presented the scores/agency rank/requested amount for the 18 projects submitted.

The group discussed the large differential between the lowest high score and the highest low score. They spoke about the possibility of adding a category for futures calls which will give more opportunities to the small towns and the difficulties for small towns in getting local match funds. There was conversation about the advantages that larger jurisdictions have in this type of funding process. A motion to recommend project awards for Board approval for the 2021 Call for Preservation Projects as outlined passed with all votes in favor.

Information & Discussion Items

- Status of the North Spokane Corridor Mr. Bob Hilmes, WSDOT and Project Engineer provided a report on:
 - Sections and projects have been completed to date (5.5 miles of roadway, 3 interchanges, ped/bike path)
 - Current and upcoming construction (2nd BNSF rail realignment, Spokane River to Columbia roadway and shared use path)
 - Forthcoming construction (Spokane River crossing, Sprague Ave to Spokane River, I-90 to Sprague Ave)

Mr. Hilmes presented a video that demonstrates how the east Wellesley Avenue interchange will operate and outlined the types and frequency of public engagement on the NSC. The group discussed using the NSC as a catalyst for economic development and maintenance of the Children of the Sun trail.

- MTP Needs Analysis— Mr. David Fletcher explained that a needs analysis is a "big picture" estimate of the cost to maintain the region's transportation system adequately and is the second part of the MTP Financial Assessment, the first part being a financial forecast. He described the development of the needs assessment methodology and involvement by the TTC and other member agency staff. A point was raised that it is never questioned ask if a road <u>needs</u> to preserved at all and maybe there should be more questions about that issue at all levels.
- MTP Public Engagement Ms. Kylee Jones provided a brief update of MTP engagement efforts since the last meeting, mainly a public meeting on June 30, the release of a new promotional video and the launch of a transportation needs survey to the public.

Spokane Regional Transportation Council 07/28/21 Transportation Technical Committee (TTC) Meeting Zoom Video Conference

Action Items

- 2021-2024 Transportation Improvement Program August Amendment All votes were in favor of a motion to recommend Board approval passed unanimously.
- Transportation Improvement Program Call for Preservation Projects Mr. Lien gave a background of the funding and Board approved policies/principles of investment. Eight agencies submitted a total of 18 projects for consideration totaling \$12M of requests; there is \$6M of funding available. He explained the scoring ranks, agency ranks and categories of funding available; he relayed comments from the Transportation Advisory Committee about their concerns the difficulties for small towns' projects scoring high enough and possible solutions for future calls.

A motion to recommend project awards for Board approval as presented carried unanimously.

Information and Discussion Items

- Metropolitan Transportation Plan (MTP) Priority Networks Mr. Lien noted that all networks (freight, vehicular, transit and bike) are being re-visited as part of the MTP update, but only the bike network will have significant changes. He explained the purposes of defining regional networks and spoke about the work done to refine and update the bike network. Next steps are the creation of an online map, launched soon, to allow for review of the draft network updates.
- MTP Needs Analysis Update Mr. Fletcher reported that there had been concern expressed regarding the time allowed for review of the needs analysis prior to making a recommendation to the Board; therefore, this item will be moved to next month. Staff is wrapping up the final parts of the analysis and will email out to the TTC by the end of the week.
- MTP Draft Chapters 1 & 2 Mr. Ulrich gave a summary of all the times the MTP has been presented since early 2020 and described the tasks that are complete or substantially complete. The basic framework of Horizon 2045 is essentially the same as Horizon 2040, with most the notable changes in Chapter 2 "Where We are". All chapters and appendices will be posted to the website for review and comments. October 8 is the deadline to submit comments/suggestions. The TTC will be asked to make a recommendation to the Board on the final draft of the MTP in November.
- WSDOT Guest Speaker: The HEAL (Healthy Environment for All) Act Ms. Char Kay and Mr. Alberto Valentin spoke about the initiatives and plans being undertaken at WSDOT in response to the recently passed HEAL Act.
