Chair Schmidt noted that excused absences had been requested by Commissioner Al French, Commissioner Mary Kuney and Matt Ewers.

Mayor Freeman made a motion to approve the excused absences. Council Member Higgins seconded. Motion passed unanimously.

Chair Schmidt noted that this is Council Member Weathers last SRTC Board meeting and he thanked him for his service over the past several years.

2 Public Comments - There were no comments.

#3 Executive Director's Report

As Ms. Bollenback had not yet joined the meeting, Ms. McMenamy reported on:

- The SRTC Interlocal Agreement (ILA) Implementation Subcommittee, established to implement portions of the ILA, met for the third time on June 3 to review the final updates to the SRTC Rules of Procedure. The updated rules will be presented to the Board in July for input. The group will also be discussing the purpose and role of the SRTC Administrative Committee.
- As discussed at last month's meeting, the Joint Transportation Commission (JTC) Working Group will
 be convening to discuss the IIJA funding split between state and local governments. To represent
 SRTC, Chair Schmidt appointed Mayor Kevin Freeman as the primary representative and Council
 Member Zack Zappone as the alternate. The JTC Working Group is expected to meet three or four
 times and the Board will be kept informed of their progress. Chair Schmidt thanked Mayor Freeman
 and Council Member Zappone for stepping forward to serve in this capacity.

Council Member Cragun made a motion to approve the Consent Agenda as presented; Council Member Higgins seconded. Motion passed unanimously.

5 Resolution #22-06 SRTC Executive Director Review

Chair Schmidt said the Board is being asked to approve the findings of the Executive Director Review Committee. Committee members were Chair Schmidt, Mayor Pam Haley, Susan Meyer, and Mike Gribner. He explained Ms. Bollenback's employment agreement specified a performance review after six months of employment; as outlined in the Resolution, the committee agreed that Ms. Bollenback was doing a very good job. He said that the committee also felt that since they were doing the six-month review almost four months late, that this review be considered the 12-month review. Chair Schmidt stated that if the Resolution is approved, they will move right into a review of Executive Director compensation based on latest data and on comparable MPOs in the state. They will look to making any necessary adjustments before the end of the year. He said in in the future they will try to synchronize the annual review and compensation review with the annual agency budget preparation process. There were no questions or discussion.

Council Member Cragun made a motion to approve Resolution #22-06. Mayor Haley seconded. Motion passed unanimously.

At 1:12 pm the following people joined the meeting in the conference room: Washington State Senator Markos Liias, Washington State Representative Marcus Riccelli, Council Member Betsy Wilkerson, Mike Gribner, Susan Meyer, Kelly Fukai, and Lois Bollenback.

Chair Schmidt introduced Senator Lijas and asked him to address the Board.

Senator Liias spoke about:

- The State Legislature passing the Move Ahead Washington transportation package
- Advancement of the North Spokane Corridor completion
- Excited to see the transformative investments being made using climate commitment funding, such as expanded transit and bicycle/pedestrian facilities
- Efficient use of multimodal systems is the most effective way to moving increasing numbers of people and freight, not simply adding more lanes or roads
- Ways of using the existing transportation system more efficiently
- Need for talking candidly about what is coming next for transportation; what will be the next set of investments

Ms. Bollenback shared information about the 2021 Unified List of Regional Transportation Priorities, ongoing regional planning efforts, the Board's legislative priority statements, the priority project list approved by the Board in 11/2021, and two-page project information sheets being produced by staff for use by member agencies for project promotion.

Senator Liias spoke about need to develop data-driven project screening tools and mechanisms. He emphasized the use of good science, evidence, engineering, and involvement by a comprehensive set of stakeholders when evaluating solutions to transportation issues.

The group discussed autonomous vehicles (AVs). Senator Liias suggested it could be helpful to launch AV technologies in small areas to build real world experience. He said there is a robust AV state level work group already but having some real experience to build on would provide useful information.

At 1:34 Commissioner Al French joined the meeting virtually. At 1:43 Senator Liias, Representative Riccelli, Mr. Gribner and Ms. Fukai left the meeting.

6 Alternate Meeting Location

Ms. Bollenback stated that SRTC plans to host a panel discussion on July 14 about the connection between land use and transportation. To accommodate the anticipated number of attendees, SRTC has reserved space at The Hive, 2904 E Sprague Ave. The regularly scheduled Board meeting will take place following the panel discussion. The Board is being asked to approve the alternative location for the July Board meeting.

Council Member Higgins made a motion to approve holding the July 14 panel discussion and SRTC Board meeting at The Hive. Council Member Wilkerson seconded. Motion passed unanimously.

#7 Transportation Technical Committee (TTC) Resolution & Bylaws

Mr. Stewart provided background information about the development of Resolution #22-07, to formalize the purpose, duties and responsibilities of the TTC and update the TTC bylaws. He recapped the prior Board discussion and development of the Resolution by the ILA Implementation Subcommittee. There were no questions or discussion.

Council Member Cragun made a motion to approve Resolution #22-07. Mayor Cooper seconded. Motion passed unanimously.

#8 Transportation Advisory Committee Appointments

Ms. Jones reported that three TAC members had to resign for various reasons and explained that staff had reached out to other applicants from the last TAC recruitment process to seek replacement members. She said the proposed new members are Charles Hansen, Caleb Newbill and Dr. Paul Vose and shared information about their transportation related interests and experience.

Council Member Wilkerson made a motion to approve the appointments of Charles Hansen, Caleb Newbill and Dr. Paul Vose to the TAC. Council Member Higgins seconded. Motion passed unanimously.

INFORMATION & DISCUSSION ITEMS

#9 2022 Transportation Planning Presentation Series: Funding

Ms. Bollenback reported that the federal government is expected to spend about \$567 B in the next five years on infrastructure and the state legislature just passed a \$17 B transportation bill. She said a high quality and resilient transportation system is expensive; she spoke about the unique challenges in the region that increase the cost of transportation infrastructure and reviewed sources of transportation revenues at the federal, state and local levels.

She explained how Metropolitan Planning Organizations provide a platform for local voices to be heard and to relay local priorities to the state and federal level. Issues to keep in mind are the area's rapid growth, limited funding opportunities in the long range and ongoing maintenance/preservation needs.

The group was asked to consider what would be most helpful to the Board in identifying the highest value solutions. Comments included:

- An overall analysis of what is needed for the region; information about where the system has gaps that need to be filled
- A visual and in-depth planner's perspective to assist in making policy decisions.
- Emphasized using a holistic approach in which the group evaluates what is bring brought to the table for funding, projects or analysis.

- Information about what projects can be implemented which will have the greatest amount of impact for the amount of money spent
- Knowing the downstream impact analysis of projects could assist the Board prioritize and work together
 as a cohesive group when going to legislators. For example, the impact of completing grade separation
 project extends far beyond just the local jurisdiction; knowing the downstream impact analysis of
 projects such as these might help the Board prioritize and work together as a cohesive group when going
 to legislators.
- The two-page project information sheets SRTC is developing is to give people key information about a project without having to read a lengthy study document
- It's difficult to balance caring deeply about meaningful projects and a purely objective framework. The prioritization process tends to be complicated and has flexible/changing criteria. Different projects get different values.
- Need a solid base of facts along with information about hidden impacts.
- Appreciates two-page project flyers.
- Consider future population growth, especially in the West Plains
- Having a variety and diversity of projects (large, small, trails, roads, transit) in the plan is important

The group was asked to consider how can SRTC stay flexible and current as the MTP (Metropolitan Transportation Plan) is updated every 4 years and the Call for Projects occurs every 3 years. Ms. Bollenback said she would like to see the Unified List of Regional Priorities and supporting package to be updated on an annual basis. The group discussed and comments included:

- The three and four year cycles for plan updates was probably adequate when they were established, but now funding sources change much more rapidly.
- The MTP is designed to be a long-range (20 + years) plan, but how could new information be incorporated to keep it the most effective.

Ms. Bollenback asked for input about how SRTC can provide the most assistance in helping to advance projects and where could the SRTC affect change in increasing revenue to the region. Mayor Freeman spoke about being prepared to advocate for solutions that work best for the region and shared comments about vehicles from Kootenai County that utilize Spokane area transportation system.

10 2024-2026 TIP Call for Projects

Ms. Jones provided an overview of the Call for Projects process so far. She stated that the #1 ranked project has requested a significant dollar amount (\$23M) and asked the Board to discuss how this should be addressed. She noted that TTC and TAC suggested consideration of a maximum award or cap. The group discussed and comments included:

Questioned how has lack of a cap impacted funding in the past. Ms. Jones said in the past the Board
was deliberate in focusing on geographic distribution of funding so it had not hindered awarding
projects. She said this is the first time that a very high scoring project has asked for such a large
portion of the funding availability.

- Emphasized the Board's focus on completing projects. With increasing costs, partial funding isn't always the most effective way to promote completion.
- Concerns about awarding any single project more than \$3M because of possible need to backfill in case of project phase delays and the need to be regional in the approach to funding
- Not sure about a hard number cap; the circumstances of a project should be reviewed. What can we
 do to move the #1 project along and not jeopardize it by under-funding. Also need to keep the
 greatest number of projects moving forward and keep our eye on meeting the federal obligation
 target.
- By funding a project that has positive regional impacts, even though the money goes to a single jurisdiction, the benefit is felt by region. Need to consider a project's circumstances.
- A \$3M cap isn't really enough to help a lot in advancing projects.
- Just awarding from the top down would limit funding to only 5 or 6 projects. There are more key
 priorities than just the top few, so suggested looking at something between a \$3M award and fully
 funding the highest ranked project.
- Mayor Haley suggested an award of \$10M to the Pines Rd project.
- Suggested looking at the list of projects using a holistic approach; what they need and what they can realistically deliver.
- Sometimes fully funding a larger project moves it out of the way for smaller projects in the next funding cycle.
- Not supportive of a funding cap. Not always the best to give a little bit to everyone. Sometime best to fund a large project to make room for smaller projects in the future. Best to look at projects on a case-by- case basis.
- This is a regional agency so the regional distribution of funds should be considered.

Chair Schmidt noted that the meeting was almost out of time, but here still is another agenda item after this one. He asked for a motion to extend the meeting by 15 minutes.

Ms. Meyer made a motion to extend the meeting to 3:15 pm. Council Member Wilkerson seconded. Motion passed unanimously.

Discussion continued:

- Ms. Note said the TTC discussed this topic at great length at the last meeting. She said it sounds like the Board is leaning towards awarding a sizeable award for the highest-ranking priority project; if that occurs the TTC will very likely ask the Board to decide how much should one agency be allowed to be awarded in a single call for project; Spokane Valley has the number one, four and seven project on the scoring list.
- Council Member Wilkerson said this is a nuanced conversation and there are many layers of
 information to be considered; she does not feel that there is enough information to advance the
 conversation any further today.
- Chair Schmidt said he is hearing a general consensus against a funding cap.

- Ms. Jones said that staff and the TIP Working Group will develop a draft plan that programs \$10M to
 the first project and then see how the funding can be spread further down the list, based upon the
 Board's input today. The draft plan will be presented to the TTC and TAC later this month and to the
 Board next month for action.
- Ms. Meyer requested that several alternatives be developed for the Board to consider next month; she suggested one which awards \$10M to the Pines Rd project and another that focus more on equitable geographic distribution.

11 Freight Mobility Strategic Investment Board (FMSIB) Priorities

Mr. Fletcher reported that FMSIB is developing a statewide list of freight investments, which includes collecting project and investment priorities from state MPOs. SRTC must deliver this information to FMSIB by 8/15/22. He shared information about eligible projects and the FMSIB prioritization criteria. Part of recent SRTC work for the MTP, Unified List of National Highway Freight Program Project list was the development of freight priorities. Those projects will be evaluated for inclusion in the FMSIB submission. He described the next steps in the process. There were no questions or discussion.

#12 Adjournment

There being no further business, the meeting adjourned at 3:14 pm.

WHEREAS, the Executive Director Review Committee recently reviewed executive director compensation at a number of organizations similar to SRTC.

WHEREAS, in order to provide fair and competitive compensation the Executive Director Review Committee finds a wage adjustment is in order for Executive Director Lois Bollenback based on performance and other agency wage information; and

WHEREAS, the Executive Director Review Committee further proposes to align future Executive Director performance reviews and review of wage with the annual SRTC operating budget process for effective initialization at the beginning of the budget fiscal year; and

NOW, THEREFORE BE IT RESOLVED, the SRTC Executive Review Committee proposes that SRTC Executive Director Lois Bollenback's annualized wage be increased 8.0 percent to \$151,200 effective July 15, 2022 and be reviewed again for SRTC budget year 2023 and recommends approval by the Spokane Regional Transportation Council Board of Directors.

TOPIC: 2024-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) CALL FOR PROJECTS

Requested Action:

Approve Resolution 22-09 to establish a 2024-2026 Program of Projects for the SRTC Call for Projects as represented in Option 1 or Option 2 (Attachments 1 or 2).

Key Points:

- After receiving guidance from the SRTC Board of Directors and input from the Transportation Technical Committee (TTC), Transportation Advisory Committee (TAC), and Transportation Improvement Program (TIP) Working Group, SRTC staff worked with applicants to develop two draft "Program of Projects" for Committee consideration. The guidance and feedback include provide geographic distribution across the region, finish projects that SRTC has previously awarded funding, and provide two funding options.
- Option 1 proposes awarding the number one ranked project as close to \$10M as possible (see Attachment 1).
- Option 2 focuses more on regional distribution of federal funds by fully funding two additional projects (see Attachment 2).
- A comparison of Option 1 and Option 2 is shown in the table on the next page. The blue cells illustrate funding changes between the two options.
- SRTC must obligate approximately \$12M per year to avoid federal funds from being sanctioned.
- Ranked projects were selected for funding for a variety of reasons, including 1) eligibility for certain funding types 2) advance regional distribution of federal funds 3) the project phases matched up with funding available each year 4) overall program balance between advancing projects to the next phase and starting new projects.
- SRTC will redistribute returned or leftover project funds to the next eligible project(s) on the contingency list. The Leftover Funds (Policy 6.5) and Contingency Funding Process (Policy 6.8) is outlined in the <u>2022 TIP Guidebook</u>.
- For more information and project descriptions listed please visit the <u>Project Descriptions</u> link.

Board/Committee Discussions:

• On 6/22/22 both the Transportation Technical Committee and Transportation Advisory Committee voted to recommended Board approval of Option 2.

- The Board, TTC and TAC discussed and shared input about this topic at meetings in January, April and May.
- In February the Board approved the 2024-2026 Call for Projects Principles of Investment, which included off-the-top awards to SRTC and Spokane Regional Transportation Management Center, set small town minimum of \$1.5M award for cities and towns with 5,000 in population or less, and set-aside \$9.2M for a future Call for Preservation projects.

Public Involvement:

All Board and committee meetings are open to the public. Projects receiving funding will eventually be incorporated into the Transportation Improvement Program, which is updated yearly and has a 30-day open public comment period.

TOPIC: 2024-2026 TRANSPORTATION IMPROVEMENT PROGRASM (TIP) CALL FOR PROJECTS

Background

- **Overview** The 2024-2026 Call for Projects was issued on 02/11/2022, to identify and prioritize transportation projects eligible for a variety of funding types totaling roughly \$32M. The awards will be for projects and programs to be executed in Federal Fiscal Years 2024-2026.
- Application Review Process Eight Transportation Technical Committee (TTC) members on the Transportation Improvement Program (TIP) Working Group reviewed & edited the SRTC 2018 Call for Projects Application to update the application. Updates included improved question clarity, minor scoring adjustments, and removed duplicative questions across sections.
- Applications Received SRTC received 51 applications from nine member agencies. Applications
 include the initiation of new projects as well as advancing existing projects to the next phase or
 to completion.
- Eligibility SRTC Staff and WSDOT Local Programs worked with member agencies to ensure application completeness, consistency with SRTC policies, and eligibility for various funding programs.
- Scoring Process Three members of the TTC, two members of the Transportation Advisory
 Committee (TAC) and two SRTC Staff reviewed and scored applications. As a result of those
 efforts, the 2024-2026 SRTC Draft Priority Scoring is attached, Attachment 1 & 2. Individual scores
 were entered into a master score sheet to develop an average overall score for each project. The
 master score sheet can be provided upon request.
- Funding Allocation Principles With input from the committees, the SRTC Board developed Principles of Investment for this Call for Projects to help guide funding decisions. Other important funding considerations include program eligibility and project delivery timelines. SRTC staff received additional feedback from the committees and direction from the SRTC Board on funding considerations related to this Call.

- In 2021, the Washington State Legislature directed the state's Freight Mobility Strategic Investment Board (FMSIB) to develop a statewide prioritized list of freight investments.
- FMSIB's process for developing this list is detailed in their Phase 1 report, which was completed last year for the 2022 Legislature. Phase 2 of this effort includes collecting investment priorities from local governments, regional planning organizations, and other statewide associations.
- In accordance with TTC feedback, SRTC coordinated with member agency staff to identify and prioritize candidate projects for inclusion in FMSIB's statewide prioritized list of freight investments. The resulting list of regional freight projects, along with the full list of candidate projects, is provided in **Attachment 1**. Details on the prioritization process and criteria is provided in **Attachment 2**.
- SRTC must provide FMSIB with its list of regional priority freight projects by 08/15/2022. FMSIB's final report is due to the Legislature on 12/01/2022.

Board/Committee Discussions:

- On June 22, both the Transportation Technical Committee and Transportation Technical Advisory
 Committee voted to recommend Board approval of the regional priority freight projects list, provided in
 Attachment 1. A motion was made to recommend Board approval of sending FMSIB the regional priority
 freight projects list, along with the full list of candidate projects, to demonstrate the extent of the
 region's freight-related needs.
- The SRTC Board discussed this item at their 06/09/22 meeting.



Key Points:

- In March, as part of the discussion series, the Board received a presentation on safety. Topics discussed included the decision-making process, what role SRTC plays in impacting human behavior, safety planning, and project weighting.
- The recently passed Bipartisan Infrastructure Law (BIL) includes a new grant program called Safe Streets and Roads for All (SS4A).
- The SS4A program is a discretionary program with \$5 billion in appropriated funds over the next 5 years and makes funds available to develop action plans or implementation plans.
- The purpose of SS4A grants is to improve roadway safety by significantly reducing or eliminating roadway fatalities and serious injuries through safety action plan development and implementation focused on all users, including pedestrians, bicyclists, public transportation users, motorists, personal conveyance and micromobility users, and commercial vehicle operators.
- To be eligible for implementation (projects) funding, an applicant must have an adopted action plan.
- Action Plan Grant awards will be based on estimated costs, with an expected minimum of \$200,000 for all applicants, and an expected maximum of \$5,000,000 for a metropolitan planning organization (MPO) or a joint application among a multijurisdictional group of entities that is regional in scope.
- The deadline for applications is 5:00 p.m. EDT on 09/15/2022.
- SRTC staff will be discussing the opportunity to apply for a regional safety action plan grant at the July Board meeting.

Supporting Information

TOPIC: CALENDAR YEAR (CY) 2022 QUARTERLY BUDGET UPDATE (2ND QUARTER: APR-MAY-JUN)

Revenues

- Through the Second Quarter (50% of Calendar Year) of CY 2022 (January June), SRTC collected \$1,246,360; 37% of the anticipated revenues for the year.
- STBG planning funds utilized in 1st quarter instead of FHWA-PL funds due to delayed fiscal year 2022 PL allocation.
- Spokane Transit Authority's (STA) share of Division Study funds are anticipated to be received in the second half of 2022.

Expenditures

Through the Second Quarter of CY 2022 SRTC spent \$1,158,637 or 34% of total anticipated expenditures for the year as follows:

- <u>Personnel Expenditures</u>: Total personnel expenditures were \$555,422 through Q2, or 45% of the CY 2022 budget amount.
- <u>Contractual and Professional Services</u>: Total services expenditures were \$494,567 year-to-date, or 26% of the total budget amount. The expenses for the Division Street Study Consultant and the 2021 State Audit charges both show a budget variance due to timing and are both nearing completion. Professional Services ETS Grant Work is pass through funding for the installation of charging stations throughout the region.
- <u>Materials and Services</u>: Total materials and services expenditures were \$44,600 year-to-date or 35% of the total budget amount. Telephone expenses are higher than anticipated due to an IT related delay in transitioning to less expensive telecom services provider. Postage variance is high due to postage purchased early in year and is only a timing issue.
- <u>Travel, Training, and Staff Development (includes and Subscriptions/Memberships)</u>: Total expenditures were \$10,850 thru Q2, or 21% of the total budgeted amount. This category continues to be impacted by COVID-19 related travel restrictions and the move to online conferences, training sessions, etc. It is anticipated that there will be increased travel and conference attendance in the second half of this year.
- <u>IT Operations</u>: Total expenditures were \$53,199 thru Q2, or 44% of the total budgeted amount. Software expense is a timing issue as ESRI/GIS software was paid in Q1 and makes up nearly 50% of 2022 budget.

Key Points:

- Per the 2021 SRTC Interlocal Agreement (ILA), SRTC member dues are set using a per capita rate and based on population estimates provided by the Washington State Office of Financial Management, excepting STA and WSDOT, whose dues are a fixed non-population-based amount. The ILA contains a provision for the City of Spokane and Spokane County to have the same membership contribution amount based on City of Spokane population.
- The current membership contribution rate is \$0.30 per capita; 2023 contribution amounts are shown on the next page in the blue column.
- Membership contributions over the past ten years have ranged between 8.5% to 14.2% of the SRTC budget. Membership contributions (local funds) are an imperative part of the budget as they serve as required match for federal grant funds as well as for the funding source for a small portion of the budget that are not grant eligible expenditures. A draft CY 2023 budget will be presented to the Board in the next few months.
- SRTC has also used membership dues to sustain an operating reserve, as federal and state grants funds operate on a reimbursement basis.

Key Points:

- An update is underway for the Coordinated Public Transit-Human Services Transportation Plan (CPT-HSTP). SRTC is leading this planning process, in partnership with STA. The current Plan was adopted in 2018.
- The CPT-HSTP addresses human services transportation within the planning area of Spokane County, with emphasis on projects and programs that serve persons with disabilities, older adults, and individuals with lower incomes. The plan's goal is to identify unmet needs, minimize duplication of services, enhance public transportation access, and identify strategies and projects to facilitate this.
- The CPT-HSTP is the guiding document for human services transportation project programming.
 Organizations applying to WSDOT's Consolidated Grant Program must cite the need they are addressing as identified in local CPT-HSTPs. Human services transportation planning is also a required component of FTA's Section 5310 grant program Enhanced Mobility for Seniors and Individuals with Disabilities.
- The planning process has focused on public outreach over the last few months, with all interested parties
 and target groups encouraged to take a survey that opened in February. With survey outreach coming
 to an end, staff will review public feedback and draft the plan update in July/August. A first draft of the
 CPT-HSTP document will be complete by 9/1/22.
- Staff will review survey results and present a draft report to the Board in September.

Board/Committee Discussions:

The Board and Committees were first updated earlier this year. Board approval of the CPT-HSTP update is scheduled for November 2022.

Public Involvement:

The planning process has extensive public involvement. The <u>Project Page</u> is the public facing site for information.

SRTC July 1, 2021 - June 30, 2023, Unified Planning Work Program;
Transportation Planning Projects to Be Conducted by Spokane Transit Authority

New Planning Project:

Division Street Bus Rapid Transit (BRT) Corridor Land Use and Infrastructure Plan

STA, in conjunction with the City of Spokane and Spokane County applied for a Federal Transit Administration (FTA) Transit Oriented Development (TOD) grant to build on the collaborative work started with the DivisionConnects project, which provided the basis for the Locally Preferred Alternative (LPA) for the BRT alignment, as well as began initial land use analysis.

Expected Outcomes/Products

Spokane County and the City of Spokane propose to jointly develop a Division Street BRT Transit-oriented Development (TOD) Corridor Land Use and Infrastructure Plan. As jurisdictions responsible for land use planning and regulation, the City and the County are positioning the Division Street Corridor for greater inclusion, housing and transportation equity, and improved economic vitality. The plan will help the County and City successfully meet the needs of each station and maintain continuity of the Division Street corridor, while celebrating the unique character of each neighborhood. Effectively, the resulting plan will be a sub-area plan to the City's comprehensive plan, with an emphasis on how fixed guideway transit, including Business Access and Transit (BAT) lanes, can improve the community. The plan will include corridor development policies and station development plans for the full corridor and will include both a proposed timeline and recommended financing strategies and will set the stage for revised TOD-focused zoning codes and resolutions.

ACTION ITEMS

• 2024-2026 TIP Call for Projects – Staff summarized the timeline, scoring process, and reviewed the differences between Options 1 and 2. There was discussion about use of toll credits, distributing funding with consideration of geographic equity, project phasing, and modifying the suggested allocations in Option 2.

A motion was made to recommend Board approval of Option 2 Program of Project as presented.

Another motion was made to recommend Board approval of Option 2 with modifications (removing funding from project #21 *Cascade Way Reconstruction* and applying those funds to project #9 *Barker Corridor: Appleway to Sprague*); there were 2 votes in favor and 15 votes against. Motion did not pass.

The vote on the original motion passed with 16 votes in favor and 1 against.

• Freight Mobility Strategic Investment Board (FMSIB) Priorities – Staff described FMSIB's directive to develop a statewide prioritized list of freight investments, which includes collecting freight project and investment priorities from MPOs.

A motion was made to recommend Board approval of sending FMSIB a focused list of projects, based on the Option B methodology, with the inclusion of the full list of projects to demonstrate the extent of the region's freight-related needs. The motion included a request that the Board reverse the reprioritization of the Pines Rd/BNSF Grade Separation project and the South Barker Rd Corridor Improvements project. Motion passed unanimously.

INFORMATION & DISCUSSION ITEMS

- **Transportation Discussion Series: Equity** Staff explained the importance of equity in regional transportation planning and efforts by SRTC to better analyze equity and strengthen equity-related criteria in project prioritization.
- **Equity Framework** Staff shared an update of the Equity Framework Working Group's activities, milestones and next steps.
- Unified Planning Work Program (UPWP) Amendment STA has requested an amendment to the 2022-2023 UPWP to add the Division Street Bus Rapid Transit Corridor Land Use and Infrastructure Plan project.
- **DivisionConnects Conclusion** Staff provided a summary of the project which launched in Q1 2020; Phase 2 report is complete and will be posted to the website soon. The Board will be asked to approve the report later this year.
- Coordinated Public Transit Human Services Transportation Plan Update Staff briefly reviewed the plan update process to date, spoke about public outreach and shared next steps. The final plan will be presented to the Board for approval in November.
- Transportation Discussion Series: Funding The meeting was out of time and this item will be presented at a future meeting.



ACTION ITEMS

- 2024-2026 TIP Call for Projects Staff summarized the process to date and described the differences between Option 1 and Option 2 program of funding. The group discussed timing and moving phases in order to meet obligation targets. A motion to recommend Board approval of Option 2 Program of Projects passed unanimously.
- Freight Mobility Strategic Investment Board (FMSIB) Priorities Staff explained FMSIB's freight prioritization project that includes receiving freight project priorities from MPOs and recapped the action taken on this item by the TTC at their meeting earlier in the day. A motion was made to recommend Board approval of submitting to FMSIB a focused list of prioritized projects based on Option B methodology along with a secondary list consisting of remaining projects to illustrate need, as proposed by the TTC. Motion passed unanimously.

INFORMATION & DISCUSSION ITEMS

- Transportation Discussion Series: Funding Staff provided an overview of the role of an MPO in funding regional transportation project, summarized federal, state and local transportation revenues, and how the Metropolitan Transportation Plan, TIP and Unified List of Regional Priorities fit into the funding conversation. The group discussed ways to identify solutions with the highest value, how SRTC can stay flexible and current and ways the agency can be more successful in meeting regional needs.
- **Equity Framework** Staff shared an update of the Equity Framework Working Group's activities, milestones and next steps.
- Unified Planning Work Program Amendment Staff explained what the UPWP is and that work plans of SRTC, STA and WSDOT are all incorporated into this single document. STA is requesting an amendment to add the Division Street Bus Rapid Transit Corridor Land Use and Infrastructure Plan project.
- **DivisionConnects** Staff shared a history of the project, the timeline, and details about the scope for work for Phase 2. The final report will be presented to the City of Spokane council and to the SRTC Board within the next few weeks. The Board will be asked to take action on the report in the fall.
- Coordinated Public Transit Human Services Transportation Plan Update Staff defined the plan and its purpose. It is required to be updated every four years and needed for several state and funding programs. Staff recapped the plan update process to date, spoke about public outreach and shared next steps. The final plan will be presented to the Board for approval in November.
