# 2 Approval of June 2022 TTC Meeting Minutes

Mr. Picanco made a motion to approve the minutes. Mr. Greene seconded. Motion passed unanimously.

# # 6 Consent Agenda (a) 2022-2025 Transportation Improvement Program September Amendment (b) Unified Planning Work Program, Amendment

Mr. Otterstrom made a motion to recommend Board approval of the Consent Agenda as presented. Mr. Jackson seconded. Motion passed unanimously.

#### # 7 Safe Streets and Roads for All: SRTC Grant Proposal

Mr. Ulrich stated that this grant, developed through the Bipartisan Infrastructure Law, provides an opportunity to develop a regional safety action plan. He recapped the discussions held in March regarding transportation safety and shared highlights of the grant program.

There are two separate funding opportunities with this grant: (1) for the development of a safety action plan and (2) for safety implementation. To be eligible for implementation plan funding, there must be an eligible action plan in place and currently no SRTC member agency besides potentially the City of Spokane has an eligible plan.

SRTC is proposing taking the lead in the development of a regional safety action plan so that all SRTC member agencies can take advantage of other future funding opportunities which require a safety action plan. An SS4A Action plan would consist of components such as engagement and collaboration, equity considerations, policy and process changes, and others. The total project cost is projected to be \$500,000 and there is a 20% local match requirement; proposed funding for the match is as follows: \$15,000 each from City of Spokane, Spokane County and City of Spokane Valley and \$55,000 from SRTC reserve funds. The application is due 09/15/22 and awards will be announced this winter. There were no questions or discussion.

Mr. Jackson made a motion to recommend that the SRTC Board direct staff to apply to the Safe Streets and Roads for All grant program. Mr. Picanco seconded. Motion passed unanimously.

#### **INFORMATION & DISCUSSION ITEMS**

#### #8 Spokane Transit Authority: Strategic Plan

Ms. Weinand provided information about STA's strategic planning process, research and data validation, industry policy trends and public outreach strategies for the strategic plan update. She shared stakeholder input and provided examples of strategies to address the draft goals of the strategic plan.

### #9 Transportation Planning Discussion Series: Economic Vitality

Mr. Fletcher shared a background of the Transportation Discussion Series which began in January and how the topics have been aimed at providing a greater understanding of planning work, specifically the Unified List of Regional Transportation Priorities (UL).

He summarized the economic vitality evaluation criteria from last year's UL process and how economic vitality as a Guiding Principle is defined in Horizon 2045. He displayed maps showing 2019 household and employment density values and how they compare to what is being forecast for 2045. Connecting jobs and housing is what creates the greatest impacts on the transportation system; identification of freight, vehicle, bicycle, and transit priority networks is a way to address the that.

Mr. Fletcher spoke about economic vitality indicators and asked the group to discuss:

- What economic vitality indicators for the region should SRTC track?
- How should we measure the economic impacts of transportation projects?
- Which economic vitality metrics should be used as criteria for the Unified List?
- Are there additional datasets?

#### Discussion points included:

- Clarification of how regional activity centers and employment density are defined.
- Discussion of which economic vitality indicators will be used as scoring criteria.
- The distance to be included around a project area when evaluating the employment density scoring.
- The employment density indicators seem to be more like land use measurements than the measurement of economic vitality impacts of transportation investments.
- The indicators don't appear to measure or distinguish between, for example, a transit project that connects two activity centers versus a road project. Or a bike path that parallels a freight corridor.
- Suggestion to add another metric regarding the proximity to a member agency's existing focus areas, for example the Northeast PDA.
- Almost any project could meet the "providing access between and within activity centers" metric.

Additional discussion of this topic will continue in the next agenda item.

#### # 10 Unified List of Regional Transportation Priorities: Process & Screening Criteria

Ms. McMenamy summarized the background and purposes behind the Unified List of Regional Transportation List (UL) development. The three major steps of this project are the creation of a Legislative Priority Statements, selecting a prioritized list of projects, and development of detailed project information sheets. These three steps form a communication tool which other agencies and organizations can use to inform State Legislators and Federal Congressional Members about the region's current priorities. She highlighted the total funding awarded to projects from the 2021 UL.

As the SRTC Board is committed to updating this list each year, development of the priority project list is underway for the 2023 legislative session. SRTC is asking member agencies to submit projects that are on their legislative or federal agendas, and/or have regional importance, and/or have a safety focus.

She compared the project evaluation criteria from last year to this cycle, noting that the modified criteria included feedback from both the TTC and TAC. Ms. McMenamy was seeking feedback on Equity ias a new focus area recommended to be included in the scoring and the draft project evaluation scoring criteria and scoring in each category.

The group discussed and comments included:

- Most projects will already be in a capital improvement program or TIP, so it may not make much of an impact to assign points to this question. Ms. McMenamy stated that last year several projects were submitted that were not currently in capital improvement programs.
- If the public outreach item is just a yes or no question, then it would assign the same number of points to a project that had outreach as part of the entire capital improvement program versus a project which had robust community engagement. Suggested adding more variability in the score for the level of engagement.

- The project submission form will allow agencies self-score and to know their approximate score immediately.
- The questions were designed to align with the Guiding Principles and the SRTC Board's goals and strategies. Staff will continue to evaluate the weighting of all the questions.
- Suggestion to change the language in the air quality question
- The question about resiliency through redundancy seems to be encouraging building new roads, which is the opposite of stewardship. Ms. McMenamy replied that in this case, the question was in routes with one way in and one way out; it's a focus on spacing. Suggestion to edit the language to ask if the project provides redundancy to a state highway.
- Also, it is important to note if a project adds to resiliency or *reduces* existing facility resiliency.
- Suggestion to combine the first two questions in the Quality of Life category.
- Discussion of the ripple effect of scoring depending on the number of questions per category.
- Discussion of how access and providing options for access to the system is being addressed.
- Definition of potential negative impacts to areas of potential disadvantage.
- Agreement that Equity should be included as a scoring area.

Next steps in the process will be to post information to the website, receive applications from member agencies from September 12 to October 5, and request approval of the process/criteria by Board in October.

TOPIC: 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

#### **Requested Action:**

Recommend SRTC Board approval of Resolution 22-16 to approve the 2023-2026 Transportation Improvement Program.

#### **Key Points:**

- SRTC is required to develop a TIP that includes a list of projects and programs to be carried out in the Spokane Metropolitan Planning Area over a four-year period.
- A TIP must be updated a minimum of every two years; SRTC updates the TIP annually.
- Any project with federal funds from the Federal Highway Administration (FHWA) or Federal Transit Administration (FTA), as well as any regionally significant projects, must be included in the TIP. Once approved by the SRTC Board, the TIP is incorporated into the Washington State TIP (STIP) then reviewed and approved by FHWA and FTA.
- Member jurisdictions and agencies have submitted their TIP project records into the Secure Access Washington Database and SRTC staff is reviewing the records and developing the TIP.
- The draft 2023-2026 TIP document can be viewed HERE.

#### **Board/Committee Discussions:**

Both the TTC and Transportation Advisory Committee were presented with a written update of the TIP development process in the August meeting packets. The Board received a presentation about the draft 2023-2026 TIP at their 09/08/22 meeting.

### **Public Involvement:**

- The draft 2023-2026 TIP document was released for public comment on 09/01/22. Notification was posted to the SRTC website, social media platforms, in the Spokesman Review and to media outlets.
- A hybrid public meeting is scheduled for 09/21/22 from 12:00pm-1:00pm. The meeting will be recorded and posted for additional viewing opportunities. Notice of the public meeting was widely distributed.
- All Board and advisory committee meetings at which this topic was discussed were open to the public.

# APPROVING THE 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) FOR THE SPOKANE METROPOLITAN PLANNING AREA

R 22-16 SRTC

WHEREAS, the Fixing America's Surface Transportation (FAST) Act of 2015 requires metropolitan planning organizations to develop a four-year program of transportation facilities, programs, and services to be completed in the metropolitan area; and

WHEREAS, the Spokane Regional Transportation Council (SRTC Board) serves as the Metropolitan Planning Organization (MPO) for the Spokane Metropolitan Planning Area (SMPA); and as the Regional Transportation Planning Organization (RTPO) for Spokane County; and

WHEREAS, Horizon 2045 is the Regional Transportation Plan (RTP) for Spokane County; and

WHEREAS, the Horizon 2045 Metropolitan Transportation Plan for the Spokane Metropolitan Planning Area has been determined to confirm with Air Quality Plans; and

WHEREAS, Horizon 2045 has been approved by the SRTC Board; and

WHEREAS, the 2023-2026 Transportation Improvement Program has been developed on the contents, goals and objectives of Horizon 2045; and

WHEREAS, the 2023-2026 TIP for the SMPA has been developed based on the contents, goals, and objectives of Horizon 2045; and

WHEREAS, the 2023-2026 TIP has been developed under the direction of the SRTC Board in consultation with local government staff, Washington State Department of Transportation (WSDOT), Spokane Transit Authority (STA), and with input from various groups and members of the general public; and

WHEREAS, the draft 2023-2026 TIP document was made available for public review and provided a 30 day comment period; and

WHEREAS, the SRTC Board is responsible for approval of the TIP and the TIP must contain all federallyfunded transportation projects in the SMPA prior to the distribution of funds to those projects; and

WHEREAS, the TIP must contain all regionally significant transportation projects in the SMPA requiring an action by the U.S. Department of Transportation, regardless of funding source, prior to the distribution of funds to those projects; and

WHEREAS, these projects must be included in the TIP before the funds can be used for these activities.

NOW THEREFORE, BE IT RESOLVED by the SRTC Board that:

- 1. The 2023-2026 TIP for the SMPA is hereby approved.
- 2. The Executive Director of SRTC is authorized to finalize and publish the 2023-2026 TIP and submit to WSDOT for inclusion in the State Transportation Improvement Program for transmittal to the appropriate agencies in the U.S. Department of Transportation.

TOPIC: UNIFIED LIST OF REGIONAL TRANSPORTATION PRIORITIES- PROCESS AND SCREENING CRITERIA

#### **Requested Action:**

Recommend SRTC Board approval of Unified List process and screening criteria.

#### **Key Points**:

- The Unified List of Regional Transportation Priorities is a strategic tool used to communicate the agency's current regional transportation priorities to state legislators and members of Congress for potential funding opportunities. SRTC is committed to annually updating the Unified List.
- Legislators and members of Congress provided feedback that the Unified List is very helpful in identifying current regional priorities and if possible, a shorter more focused list would be beneficial.
- The 2023 Unified List update process and development steps can be found in the **Attachment** to the memo. SRTC is currently accepting Unified List project submittals through 10/5/2022.
- The TTC, TAC and Board provided input on draft process and screening criteria last month. The updated draft criteria for action this month is provided, see the **Attachment**. A redline version on the criteria changes from your last meeting is also provided for your convenience linked here.
- Board member feedback included that equity should be a focus area for scoring, safety should be emphasized as a strategy, and additional economic development criteria should be considered that accounts for annual growth and includes job creation. SRTC Staff indicated we are evaluating future opportunities to integrate new economic development information and criteria in the future.

#### **Board/Committee Discussions:**

The Transportation Technical Committee and Transportation Advisory Committee received information and provided input during the *Transportation Discussion Series* each month in 2022. Both committees provided input on the Draft Unified List criteria at their 08/24/22 meeting. The Board provided input at their 9/8/22 meeting.

# Project Evaluation Criteria DRAFT Includes 8/24 TTC & TAC Feedback

The Unified List of Regional Transportation Priorities is a strategic tool used to communicate the agencies current regional transportation priorities to state legislators and congressional members for potential funding opportunities. SRTC is committed to annually updating the Unified List.

# Economic Vitality 30 points possible

Targets transportation investments aimed at the development of a multi-modal system that enhances accessibility and connections among regional activity centers.

#### Question 1a (5 points):

Does the project provide access within or between two or more regional/local activity centers?

Question 1b (5 points):

If yes to 1a, does the project either: A)contain active transportation or transit-supportive elements and improve access in a transit focused, mixed focus, or local activity center; or B) contain freight-supportive elements and improve access in a freight or mixed focus activity center.

#### Question 2 (10 points):

What is the forecasted 2045 population density of transportation analysis zones (TAZ) within a 0.25 mile buffer of the project?

#### Question 3 (10 points):

Is the project located on the FGTS? Points scaled based on FGTS classification—T-1 through T-5

# Cooperation & Leadership 30 points possible

Relates to SRTC's role to provide a regional forum to identify regional transportation needs, establish regional priorities, and develop strategies to acquire funding in accordance with federal and state planning requirements.

#### Question 1 (15 points):

Is the project identified in the local TIP (or Transit Development Plan) and/or Comprehensive Plan?

#### Question 2 (15 points):

Is the project identified in other agency plans and/or has it gone through a documented public outreach process?

# Stewardship 30 points possible

Emphasizes transportation investments that maximize positive impacts on the human environment while minimizing negative impacts to the natural environment.

#### Question 1 (10 points):

Does the project incorporate electrification or other clean fuel strategies?

#### Question 2 (10 points):

Does the project increase resilience by adding redundancy in areas of limited connectivity?

Note: This question was listed under economic vitality in 2022 Unified List.

#### Question 3 (10 points):

Does the project reduce air quality emissions or VHT/VMT?

Note: This questions relates to the State Vehicle Miles of Travel Targets Proviso.

# Operations, Maintenance & Preservation

30 points possible

Involves strategically investing limited resources to maximize the operations and physical condition of the transportation network.

#### Question 1:

Does the project incorporate TDM/TSMO solutions or improve capacity without adding travel lanes or roadways?

\*This criteria directly relates to federal transportation performance management (TPM) requirements.

#### Question 2:

Does the project improve NHS pavement/bridge condition or contributes to STA's adopted public transit asset management targets?

\*This criteria directly relates to federal transportation performance management (TPM) requirements.

#### Question 3:

Does the project address a need identified in the SRTMC ITS Architecture Plan, SRTMC Implementation Plan, or local technology plan?

# Safety & Security 30 points possible

Focuses on designing a safe and secure system for all transportation modes through best-practice design, operational improvements, education and outreach, and technological strategies.

#### Question 1 (15 points):

What countermeasures does the project incorporate to address crashes that result in serious or fatal injury? If the project is a transit project, how does it contribute to STA safety targets? Review collision data to see if countermeasures address existing issues.

\*This criteria directly relates to federal transportation performance management (TPM) requirements.

#### Question 2 (15 points):

Is the project identified in a state or local plan, or an approved prioritized list of safety projects?

# **Quality of Life**30 points possible

Aims to improve choice and mobility by providing safe and convenient transportation options for people of all abilities.

#### Question 1 (10 points):

Is the project on the Regional Bicycle Priority Network and does it have active transportation elements; or does the project add a new pedestrian connection or feature beyond what is required for ADA compliance?

#### Question 2 (10 points):

Is the project on the Regional Transit Priority Network and does it have a transit-supportive element?

Examples include new/enhanced transit, bus stops, AT facilities, pavement work, signal improvements, TSMO improvements.

#### Question 3 (10 points):

Does the project extend or fill gap in one of the regional trails, or provide new active transportation connectivity to one of the regional trails?

Does the project include potential negative impacts to areas of potential disadvantage? If yes, please describe efforts to mitigate these impacts.

**TOPIC: EQUITY PLANNING FRAMEWORK** 

#### **Requested Action:**

None. For Information and discussion.

#### **Key Points:**

- SRTC's State Fiscal Years 2022-2023 Unified Planning Work Program (UPWP) includes provisions for SRTC to pursue and equity planning framework in 2022.
- SRTC is working on an updated equity planning framework to maximize regional competitiveness for funding opportunities, meet state and federal requirements, improve existing equity planning methodologies, and positively impact our community.
- Earlier this year, SRTC assembled a working group comprised of TAC and TTC members as well as one Board member. The working group has met seven times – once each month in March, April, May, June, July, August, and September. One more work group meeting will be held in October.
- The working group has begun prioritizing recommendations from a wide variety of potential tools and strategies that were discussed throughout the year.
- A rough draft list including important themes and likely recommendations that have emerged is included with this memo as an attachment. If you have questions or if you would like additional information, please reach out to the SRTC staff contact.
- At their October meeting, SRTC will be asking the TTC to review a draft framework document and discuss potential changes and improvements.
- At their November meeting, SRTC will be asking the TTC to recommend approval of the Equity Planning Framework to the SRTC Board.

#### **Board/Committee Discussions:**

The Transportation Technical Committee was presented an update on this item during their June meeting. This item was first presented to the TTC in January.

The final document will incorporate additional feedback and include additional information on the framework development process. All items are recommendations and do not reflect current SRTC directives.

Through this work, five important themes emerged which we utilized to help organize our recommendations. The five themes are:



**Engagement Processes** 



**Increasing Access to Opportunities** 



Sustainability, Health, and Safety



**Equity Spending and Project Prioritization** 



**Performance Evaluation Metrics** 



## **Top Recommendations – Equity Planning Framework**

The following list includes the top recommendations by theme. Items are not in any particular order, and some items may appear under more than one theme.



## **Engagement Processes**

- Recommendation: Establish an equity work group or advisory group as a recurring activity. This could include members of the TAC and/or TTC, Board, and community representatives. The group could complement and support external SRTC outreach to EJ communities/service providers.
  - O Purpose and benefit: If established, an equity advisory group could help SRTC by serving two key functions. On the front end, the group could help SRTC by advising the agency on both targets and assessment criteria that may be inputs into project-level assessment. On the back end, the group could help review projects and programs to determine which built projects have been particularly effective in their stated aims vs. those that have been less positively impactful. The group would also help ensure equity remains a living, evolving topic in SRTC's planning process.
- **Recommendation:** Ask project sponsors to report the level of engagement during planning and outreach. Support projects with greater community support.
  - o **Purpose and benefit:** By asking sponsors to report the level of engagement and setting meaningful definitions to help clarify what qualifies as meaningful engagement SRTC seeks to ensure that projects that truly benefit their local communities rise to the top when it comes to equity. SRTC seeks to ensure that all communities' voices are heard and improve our visibility with regard to who we (and our members) are reaching and who we are not.



- **Recommendation:** Add an equity statement into SRTC's Public Participation Plan as an update.
  - O Purpose and benefit: In alignment with the recommendation to include equity among SRTC's guiding principles, an equity statement included in our Public Participation Plan would make SRTC's emphasis clear to both the public and our stakeholders. It would build on work done during the last PPP update and indicate the important place of equity within our public engagement protocols.
- Recommendation: Staff-level training for SRTC staff and SRTC members. This could be administered by SRTC staff, or through a common third-party resource (such as WSDOT). Important topics include: What does meaningful engagement look like? What does SRTC mean by equity?
  - Purpose and benefit: It is critical that SRTC staff and member agencies understand how we analyze equity at SRTC to maximize meaningful participation in agency activities. Likewise, it is critical that agencies who may be asked to report levels of engagement have a common understanding of what meaningful engagement means and what that practically looks like within the transportation planning process.
- Recommendation: Put forth an SRTC policy (or Public Participation Plan update) to formalize and standardize compensation and incentives for public input in targeted outreach situations.
  - Purpose and benefit: SRTC has in the past pursued several different incentive strategies for several different outreach efforts. A single policy, informed by research, would help standardize and organize our protocols, as well as provide guidance for when incentives may bolster the effectiveness of targeted outreach efforts.





## **Increasing Access to Opportunities**

- Recommendation: An equity planning assessment for projects (such as WSDOT's
  forthcoming environmental justice assessment tool or the University of South Florida's
  Center for Urban Transportation Research's Transportation Equity Toolkit).
  - Purpose and benefit: A well-rounded equity assessment for projects would help provide a backbone for equity project scoring through multiple planning efforts. If equity is included among SRTC's guiding principles, criteria and targets could be set by the SRTC Board with the input of SRTC's committees and staff. Importantly, SRTC would have the opportunity to review and potentially adopt the environmental justice assessment set by the state of Washington as part of the HEAL Act implementation process. That assessment tool, once completed (no later than 7/1/23), will be applied at the state level to all projects and programs (≥ \$15 million) receiving state dollars.
- Recommendation: Make use of origin/destination data such as connectivity and access between EJ area origins and key destinations. This process could be utilized to help identify areas where projects may be impactful, as well as to help review project impact.
  - Purpose and benefit: By analyzing the important connections between potentially disadvantaged populations and key destinations such as employment, services, and other quality of life destinations SRTC could help identify barriers to access as well as potential projects that are likely to improve connectivity. SRTC would also be able to look at built projects and their impact on the flow of people. As an initial step, SRTC would need to identify an effective origin/destination data source and acquire data.





## Sustainability, Health, and Safety

- **Recommendation:** Improve SRTC Safe & Complete Street Policy by identifying potential areas to improve transportation equity.
  - Purpose and benefit: This recommendation would help SRTC improve the overall equity of the region's transportation system by identifying additional areas to improve safe and complete streets and/or additional projects that should be included under the safe & complete streets policy.
- **Recommendation:** Work on bridging the gap between what's designed and what's implemented/built. Work with jurisdictions to ensure accessible design via review of PE plans after design and review of project upon completion.
  - Purpose and benefit: The equity work group heard from neighborhood councils that there is sometimes a gap between the final design specifications of projects and the lived transportation habits of members of the local community. Projects as built should fulfill the equity-related goals that they initially set out to achieve. This recommendation seeks ways to improve communication so that the community is involved and fully informed when expectations evolve throughout the stages of project development.



## **Equity Spending and Project Prioritization**

- Recommendation: Formalize that equity will be included as a guiding principle. This
  would ensure equity is used as performance measure for certain major efforts (MTP,
  TIP, Unified List, etc.) and allow the Board to set targets. This would include
  conversations and multilateral decision-making with jurisdictions.
  - Purpose and benefit: ncluding equity among SRTC's guiding principles was a strong recommendation from the work group and would ensure that equity remains important to how we function at all levels as an organization. Equity as a guiding principle would also help frame future activities and standardize transportation equity assessment among project evaluation criteria for the agency's major planning and project prioritization efforts.



- Recommendation: An equity planning assessment for projects (such as WSDOT's
  forthcoming environmental justice assessment tool or the University of South Florida's
  Center for Urban Transportation Research's Transportation Equity Toolkit).
  - o **Purpose and benefit:** A well-rounded equity assessment for projects would help provide a backbone for equity project scoring through multiple planning efforts. If equity is included among SRTC's guiding principles, criteria and targets could be set by the SRTC Board with the input of SRTC's committees and staff. Importantly, SRTC would have the opportunity to review and potentially adopt the environmental justice assessment set by the state of Washington as part of the HEAL Act implementation process. That assessment tool, once completed (no later than 7/1/23), will be applied at the state level to all projects and programs (≥ \$15 million) receiving state dollars.
- **Recommendation:** Address lack of investment by tracking percent of investment likely to be used by / targeted towards EJ communities.
  - Purpose and benefit: It is important that SRTC begins to track investments in transportation equity so that we can better evaluate historical levels of investment, where we are, and our progress. Doing so grants the agency increased awareness of potential needs as well as investment gaps and inequities. Additionally, a better understanding of where SRTC dollars have gone and where they're going would better position the agency to get ahead of discussion at the state (+ federal) level.





# **Performance Evaluation Metrics**

- Recommendation: Establish an equity work group or advisory group as a recurring activity. This could include members of the TAC and/or TTC, Board, and community representatives. The group could complement and support external SRTC outreach to EJ communities/service providers.
  - Purpose and benefit: If established, an equity advisory group could help SRTC by serving two key functions. On the front end, the group could help SRTC by advising the agency on both targets and assessment criteria that may be inputs into project-level assessment. On the back end, the group could help review projects and programs to determine which built projects have been particularly effective in their stated aims vs. those that have been less positively impactful. The forementioned equity work group or advisory group could play a role in this item.
- Recommendation: Make use of origin/destination data such as connectivity and
  access between EJ area origins and key destinations. This process could be utilized to
  help identify areas where projects may be impactful, as well as to help review project
  impact.
  - Purpose and benefit: By analyzing the important connections between potentially disadvantaged populations and key destinations such as employment, services, and other quality of life destinations SRTC could help identify barriers to access as well as potential projects that are likely to improve connectivity. SRTC would also be able to look at built projects and their impact on the flow of people. **TOPIC: COORDINATED PUBLIC TRANSIT – HUMAN SERVICES TRANSPORTATION PLAN UPDATE** 

#### **Requested Action:**

None. For information and discussion.

#### **Key Points:**

- The planning process to update the Coordinated Public Transit-Human Services Transportation Plan (CPT-HSTP) began in early 2022. SRTC is leading the process, in partnership with STA. Since February, all interested parties and target groups have been encouraged to provide input through a survey. With the survey closing in August, staff has incorporated this feedback and completed the <u>Draft 2022 CPT-HSTP</u> and <u>Draft Appendices</u>, published on September 1.
- The Draft CPT-HSTP is currently in a public review period, with a comment deadline of 10/14/22. Staff
  will be presenting an action item on the final plan at the October TTC meeting, with the TTC
  recommendation on the final plan taken to the Board of Directors at their November meeting.
- The CPT-HSTP addresses human services transportation within the planning area of Spokane County, with emphasis on projects and programs that serve persons with disabilities, older adults, and individuals with lower incomes.
- The CPT-HSTP is the guiding document for human services transportation project programming.
   Organizations applying to WSDOT's Consolidated Grant Program must cite the need they are addressing as identified in local CPT-HSTPs. Human services transportation planning is also a required component of FTA's Section 5310 grant program Enhanced Mobility for Seniors and Individuals with Disabilities.

#### **Board/Committee Discussions:**

The Board was updated with an informational memo in September 2022. Committees were last updated in June 2022. Board approval of the CPT-HSTP update is scheduled for November 2022.

#### **Public Involvement:**

The planning process includes extensive public involvement. The <u>Project Page</u> is the public facing site for information. The Draft 2022 CPT-HSTP is posted on the Project Page and is open for public comment until 10/14/22. Comments may be submitted to staff contact Jason Lien.
