Responsibilities include initiating a variety of communications and outreach activities to identify and engage diverse populations, to build business and advocacy group relationships, to ensure equity and to expand visibility of the organization.

This role is responsible for enhancing media relations, designing a variety of outreach materials, and ensuring proactive communications that involve diverse techniques including in-person events and social media. The CEP Coordinator will work collaboratively with the public, staff, and stakeholders to increase SRTC's level of community involvement, improve linkages with community members and entities, and enhance communication flows. The Coordinator will collaborate with planning staff to develop project specific messaging, materials, presentations, and other engagement tools.
