Charlie Allcock is an industry leader in the transition of transportation to use zero-emission technology to move people and freight. He provides strategic consulting services to clients in heavy-duty vehicle manufacturing, electric utilities, and other organizations active in clean transportation.

An electric utility industry veteran of over four decades, he led a number of innovative transportation electrification projects as Director of Business Development at Portland General Electric (PGE), Oregon's largest electric utility, and was recognized as a global leader in transportation electrification by Automotive News with the Electrifying 100 award.

Charlie serves as the Senior Infrastructure Advisor to the International Council on Clean Transportation (or ICCT, https://theicct.org/) and is active in a number of their projects worldwide, including the EU, North America, and China. He also advises Japanese electric utilities around transportation electrification developments in the US.

Charlie recently led early utility efforts in a 1400-mile public electric refueling corridor along the West Coast, contributed to Avista's Transportation Electrification Plan, advises Seattle City Light on their transportation electrification strategy, and is actively involved in electric truck deployment projects in Southern California.

RICK GIDDINGS CITY OF SPOKANE, DIRECTOR OF FLEET SERVCES

Rick Giddings currently serves as the Director of Fleet Services for the City of Spokane, a position he has held for nearly three years. Prior to his time with the city, Rick spent over 30 years working with Les Schwab Tire Centers in Washington and Idaho.

He and his team are focused on transitioning the city's fleet to cleaner and more sustainable options, including electric and other alternative fuel vehicles. Rick is also actively involved in developing a strategic network of vehicle charging infrastructure at city facilities.

Under his leadership, Spokane's Fleet Services Department employs multiple strategies to achieve its sustainability goals. These strategies, which include their recent adoption of Renewable Diesel and Renewable Natural Gas for vehicles that are not due for replacement or don't yet have a viable zero emission option available, have resulted in a dramatic reduction in the city fleet's carbon emissions.

CARL SEE WA STATE TRANSPORTION COMMISSION, DEPUTY DIRECTOR

Carl See is the Deputy Director for the Washington State Transportation Commission (WSTC). He has worked in the public sector transportation industry for nearly 15 years, both at the WSTC and at the Washington State Department of Licensing.

He has a focus on examining and communicating about transportation finance and policy. Mr. See contributes to the WSTC's study of future transportation policy considerations, including for the state's tolling and ferry systems, the WA Road Usage Charge pilot project, and the Autonomous Vehicle Work Group. Mr. See also leads the WSTC's ratesetting process for Washington State's five tolled facilities, and for the Washington State Ferry system.

Mr. See earned his Master of Public Administration from the Evans School of Public Policy and Governance, University of Washington, and his Bachelor of Arts in Government from Claremont McKenna College.
