SRTC seeks public input on a proposed amendment to the 2025-2028 Transportation Improvement Program

The Spokane Regional Transportation Council (SRTC) is asking community members to provide input on a February Amendment to the [2025-2028 Transportation Improvement Program](#) (TIP). The TIP is a comprehensive four-year program containing regionally significant transportation projects and funding allocations.

The proposed amendment would amend one existing project and add a new one. Both amendments are for the City of Spokane Valley. The new project is proposed to be added to the TIP because Spokane Valley received \$1.5 million in Federal Safety funding for the 8th and Barker roundabout.

What is the TIP?

The TIP contains a wide variety of transportation projects in Spokane County. Some examples include projects that maintain and preserve existing roads, bicycle and pedestrian projects, public transit investments and bridge repairs. The document includes project names and descriptions, jurisdictions sponsoring them, funding attached to each project and where the funding came from (local, state or federal dollars).

The TIP is amended monthly throughout most of the year. Jurisdiction agencies submit Amendments to SRTC, which includes projects to add, change or remove from the TIP. Often, amendments are submitted as funding becomes available or projects move toward being ready for construction.
